KKR Group Holdings Corp. is a general partner of KKR Fund Holdings L.P. and the sole shareholder of KKR Fund Holdings GP Limited. KKR & Co. Inc. is the sole shareholder of KKR Group Holdings Corp. KKR Management LLC is the controlling shareholder of KKR & Co. Inc.
2. Messrs. Henry R. Kravis and George R. Roberts are the designated members of KKR Management LLC.
3. Each of the Reporting Persons may be deemed to be the beneficial owner of all or a portion of the securities reported herein.
